- All "For Sale" signs must conform to Viridian guidelines and specifications, and confirm to Viridian color specifications.
- One (1) 24"x 36" sign is permitted in the front of the property.

- One extra information sheet container is allowed. <u>Tubular containers are not permitted.</u>
