

**VIRIDIAN MILLION DOLLAR CLUB 2018 first quarter SALES INCENTIVE
CONTEST RULES**

To qualify as a Viridian Million Dollar Club Member, qualified REALTOR[®]/Broker must submit a completed entry form and comply with all contest rules (see below), and must have sold at least one new home in Viridian during the qualifying period of January 1, 2018 – March 31, 2018. There will be two grand prize winners. The winners will be notified by Viridian.
